

An Update on Strengthening America's Communities

Initiative (SACI) In 2005, the administration proposed SACI as a plan for consolidating eighteen federal programs that promote economic development in the nation's communities. The fiscal 2006 budget did not include funds for the implementation of SACI. Hear from the Department of Commerce's senior economic development policy maker about the administration's future plans and come prepared with questions.

Rulemaking and Guidance: Implementation of

<u>SAFETEA-LU Listening Session</u> Federal agencies are currently drafting rules and guidance for provisions in SAFETEA-LU. This session will provide insight into the process and allow participants the opportunity to provide input to agency officials.

<u>The Future of Water Quality Planning</u> With scarce resources for domestic spending, funding for Water Quality Programs is at risk. This session will focus on the administration's perspective, in particular the 2007 congressional budget request. Congressional Committee Staff will proide insights to potential hurdles that will have to be overcome to maintain the core water programs at adequate funding levels.

<u>Serving the Needs of Seniors</u> Regional Councils serve as Area Agencies on Aging (AAA) and administer programs that provide valuable services for America's seniors. The White House Conference on Aging held in December 2005 is the 5th conference held to assess challenges of changing demographics and their impact on how to best address the concerns of older Americans.

<u>The Future of Multimodalism</u> Air transport, passenger rail, and other intercity transportation play an important mobility role in the United States. These modes have unique challenges and growth opportunites in the near future. Representatives of passenger rail, airlines, and transit providers will discuss how we can shape a national policy to move people more efficiently.

<u>Air Quality Roundtable</u> The passage of SAFETEA-LU will mean changes to how we implement conformity through the regulatory process. NARC continues the series of integrating air quality and transportation planning workshops that provide information on the conformity process and how it will change. FHWA, EPA, and Congressional representatives will discuss what this means.

The Challenges of Homeland Security and Community

- <u>Preparedness</u> The ongoing threats of acts of terrorism and unanticipated events such as natural disasters require a coordinated strategy and response across the nation's communities. Regional approaches are critical to a seamless interface of services, resources, and supplies. The devastation caused by hurricanes Katrina and Rita reminded the nation of the critical nature of responding timely and effectively.
- Freight and Goods Movement Policy Freight and goods movement is critical to the economy of the United States. Freight systems have become severely congested due to just-in-time delivery, consolidated operations, and overseas trade. To accommodate future growth and maintain our quality of life, major investment is needed in the goods movement system. This session will present the outlook for a national goods movement policy, including solutions to freight congestion issues.

Investment Decisions for Operations (Elected Officials)

FHWA is conducting a survey from the Joint Program Office on User Needs Assessment. They are interested in hearing how elected officials make investment decisions and what resources they use in their decision making.

<u>Workforce Development for a Global Economy</u> Competitiveness in the global economy means having a trained workforce to meet new demands. Assuring Americans have the skills set to effectively compete in the world market place supports the nation's economic position. The workforces reauthorization act will be an agenda item for the second session of the 109th Congress.

<u>The Future of Transportation Finance</u> As the need for transportation infrastructure exceeds the public funds currently available, innovative solutions to transportation finance are being proposed and experimented with. This session will bring together a panel of experts on transportation finance including public/private partnerships, new government programs, and transportation user fee systems.

The Synergy of Cooperative Conservation, Green

Infrastructure, and Landcare The White House Summit on Cooperative Conservation encouraged innovative strate gies of collaboration at the local, state, and federal levels. NARC has ongoing projects on Green Infrastructure and Landcare and is working toward getting more of these types of projects on the ground. The session will be an inspiration to all.
