This week NTL staff members are attending First International Open Government Data Conference. NTL is working with RITA's Research, Development, and Technology Office to host their new database. It will track all research projects that DOT provides partial or full funding for. Included are UTC's and FHWA's Centers of Excellence; to be launched around TRB.

Quarterly Information session for employees was held on November 17th. Several people were interested in NTL integrated search and different databases available. NTL is preparing for summer and spring break interns. Tasks that they will be working on include processing DOT Historian collection, cataloging special projects, reference, developing and updating NTL marketing materials and short term cataloging projects.
